Child Development Specialist Apprenticeship

Apprentices who complete this program will earn the Child Development Associate Credential (CDA). They will complete 4,000 hours of on-the-job learning (OJL) and 288 hours of related training instruction (RTI). They are eligible for up to 288 hours of credit for prior learning for the RTI portion of the program and no more than 2,000 hours credit for prior experience for the OJL portion of the program.

Both Youth (High School students and up to age 21) and Adults can complete this track.



Youth Child Development Specialist Apprenticeship

- Kentucky high schools offer juniors and seniors an ECE Pathway through TRACK and Family and Consumer Sciences at no cost to employers
- Students in this pathway can work in preschool, head start and childcare programs while training
- Apprentices who complete this program will earn the Child Development Associate Credential (CDA). They will complete 4,000 hours of on-the-job learning (OJL) and 288 hours of related training instruction (RTI). They are eligible for up to 288 hours of credit for prior learning for the RTI portion of the program and no more than 2,000 hours credit for prior experience for the OJL portion of the program.

Early Childhood Educator Apprenticeship

Apprentices who complete this program will earn an Interdisciplinary Early Childhood Associates Degree (AA). They will complete 2,000 hours of on-the-job learning (OJL) and 144 hours of related training instruction (RTI). They are eligible for no more than 1,000 hours credit for prior experience for the OJL portion of the program.



Early Childhood Administrator Director Apprenticeship

Apprentices who complete this program will earn the Child Development Associate Credential (CDA). They will complete 4,000 hours of on-the-job learning (OJL) and 288 hours of related training instruction (RTI). They are eligible for up to 288 hours of credit for prior learning for the RTI portion of the program and no more than 2,000 hours credit for prior experience for the OJL portion of the program.

This is currently in process of being aligned to the career lattice to hold the same merit as the director credential, as an alternative pathway.



Currently, 3, 4, and 5 star child care, head start, early head start, and public preschool settings are eligible to apply to participate in the program.

All participants must complete an application that is scored and admittance to the program is based off of the score of the application.



Why Pulaski County Schools chose to participate?

Memorial Education Center

- Public Preschool and Child Care Programs from Birth to Eight Years of Age
- Located in Somerset, KY
- Funding is through State Grant, Written Grants, CCAP, and Tuition

Why choose to participate in the apprenticeship program?

- Offers opportunities for employees to continue their education, and participate in trainings and events
- Provides support through mentorship while building relationships with coworkers
- Provides additional income, assistance with tuition/expenses, and a laptop





What is the impact of the program?

- We currently have staff participating in the Early Childhood Administrator Director Apprenticeship and Early Childhood Educator Apprenticeship.
- A total of 12 apprentices (four certified teachers that teach public preschool, five preschool assistants, and three child care providers) and one mentor, which is the principal of the school.




Every program can lead to many opportunities.
